Even though the access to all screws, bolt, nuts, etc. is not PHYSICALLY RESTRICTED, Positech innovation STRONGLY recommend that you and/or caregiver DO NOT MODIFY ANY OF THE ORIGINAL ADJUSTMENTS MADE BY YOUR PROFESSIONNAL CLINICIAN, otherwise injury or damage may occur. If you feel discomfort, please contact your qualified clinician to discuss your concerns. If your condition changes with time, please visit your qualified clinician for new adjustment settings.

Positech innovation products are specifically designed and manufactured for use in conjunction with Positech innovation accessories. Accessories designed by other manufacturers have not been tested by Positech innovation and are not recommended for use with Positech innovation products.

Before using SUMMUS, the clinician should teach you and/or the caregiver why & how the required support of the head is obtained, how to manipulate the headrest system, its proper adjustments & the safety rules. Not receiving the proper training may result into discomfort or severe injury.

Before each use of SUMMUS, ensure that SUMMUS is fully functional by conducting a thorough check of all hardware components and fasteners. If loose, secure the components to the initial torque settings while RESPECTING THE ORIGINAL INSTALLATION CONFIGURATIONS. In addition, verify that all hardware components and the headrest foam cushion do not show substantial deterioration. If this verification process is not done correctly, a risk of equipment breakdown, damage to components and/or user injury could occur.

The selected shape of the SUMMUS foam cushion should not create pressure to the ears, eyes, throat, neck, jawbone, occipital/temporal areas.

All accessories or replacement parts not provided by Positech innovation may not be used in conjunction with our SUMMUS headrest system as it may affect negatively its performance, cause safety issue and void the warranty.

SUMMUS headrest system should not be used at all times to push, pull and lift the wheelchair as it may result into excessive wear and impact of the user safety.

## 3.0 WARRANTY & LIMITATION OF LIABILITY

Metallic components of products purchased from Positech are warranted against defects in workmanship and material for a period of two (2) years from the date of delivery of the product to the first consumer.

Textile components of products purchased from Positech are warranted against defects in workmanship and material for a period of ninety (90) days from the date of delivery of the product to the first consumer.

Non-metallic and non-textile components of products purchased from Positech are warranted against defects in workmanship and material for a period of one (1) year from the date of delivery of the product to the first consumer.

Positech's obligations under this warranty are limited to replacing (transportation costs at the Dealer's expense) or repairing, at its option, any products which under normal and proper use and maintenance are proved to be defective to Positech, in its sole discretion, within the warranty period, provided that Positech has had the opportunity to inspect them.

This warranty is not transferable and only applies to the first consumer purchase through an authorized Positech dealer.

This warranty does not cover products or parts thereof which (i) normally wear out due to the general wear and tear of standard use, (ii) are modified, altered, inadequately stored or kept, or (iii) are not installed, adjusted, used or maintained in accordance with Positech's instructions. In addition to the foregoing, this warranty does not cover punctures, tears, or burns, exposure to moisture, exceeding the weight limit and <acts of nature> ( ex. Flood, Earthquake, Tornado, etc. ). Any substitutions of supplied hardware also void the warranty.

THE FOREGOING IS POSITECH'S SOLE WARRANTY, ALL OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING WARRANTIES OF FITNESS FOR PURPOSE AND MERCHANTABILITY, ARE EXCLUDED AND DISCLAIMED TO THE FULL EXTENT PERMITTED BY LAW. 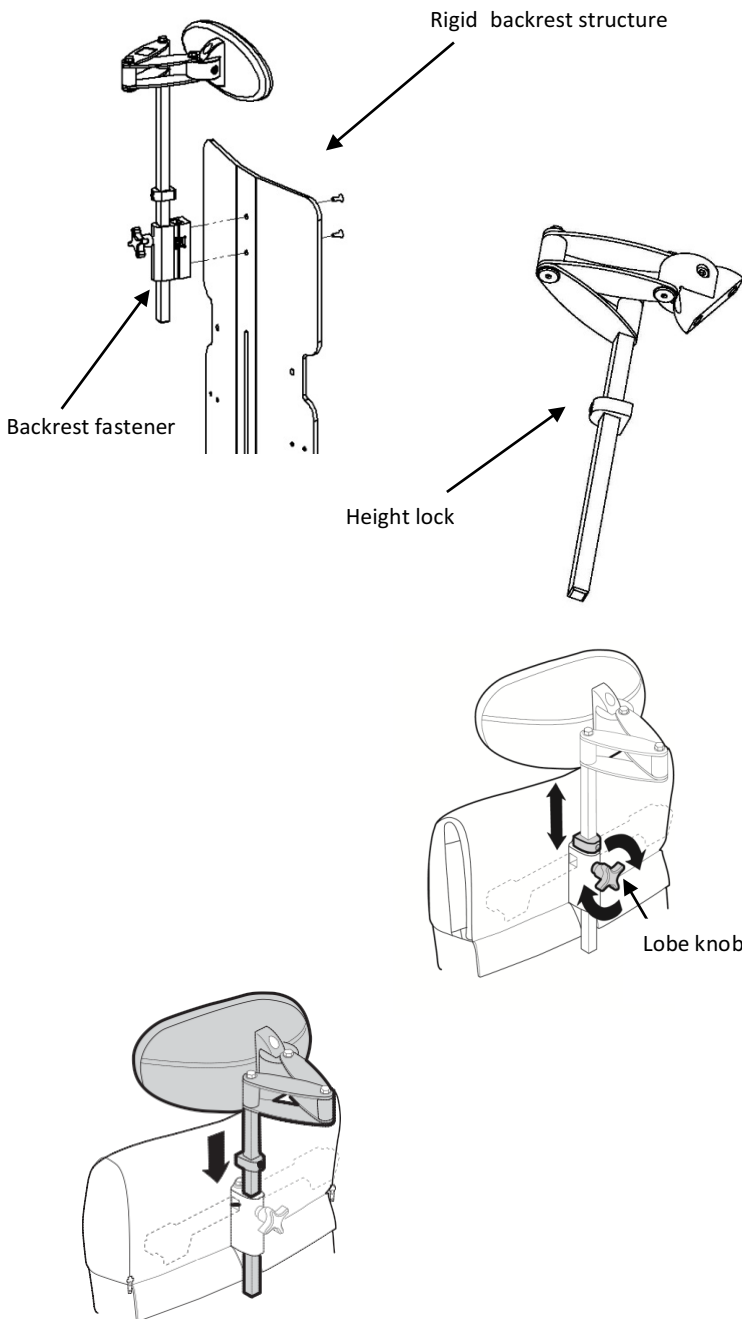

## 5.2 SUMMUS HEADREST SYSTEM with FLEXUS



The SUMMUS headrest system is attached to the rigid backrest structure of FLEXUS.

The clinician has pre-set the required height of the headrest cushion, using a height lock.



**WARNING :**

**DO NOT MODIFY THE ADJUSTMENT OF THE HEIGHT LOCK NOR THE CONFIGURATION OF THE MULTI-DIRECTIONAL SUPPORT.**

Turn **counter clockwise** the lobe knob to allow the insertion of the stem into the support all the way until the height lock comes in contact and is blocked by the backrest fastener.

Turn **clockwise** the lobe knob to lock the stem in place.

To pull out the headrest stem, use the lobe knob and turn **counter clockwise**.

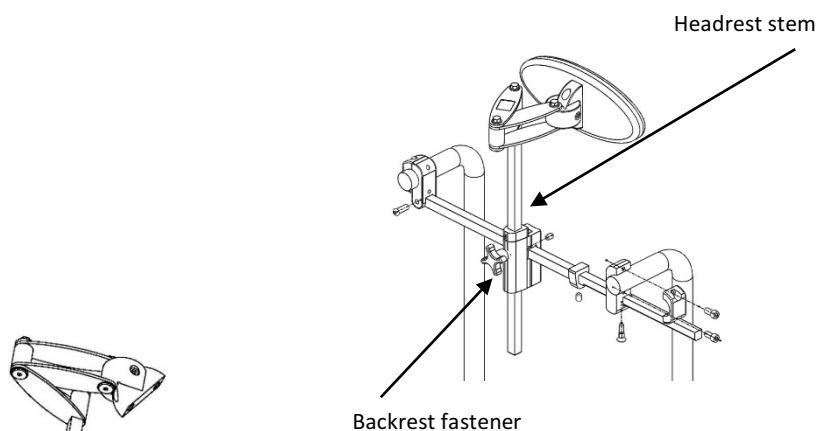


**WARNING :**

**TO AVOID LOSING THE LOBE KNOB, always keep it screwed into the support.**

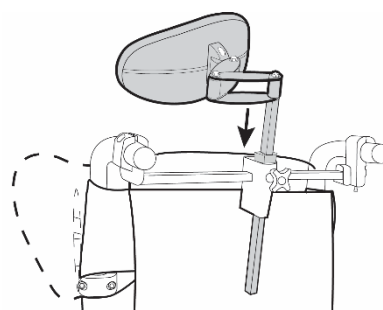
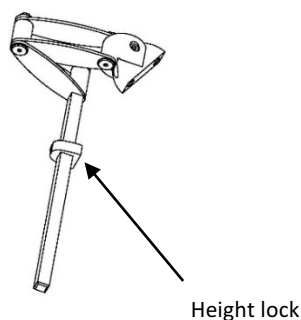


### 5.3 SUMMUS HEADREST SYSTEM with BACKUS & CURVUS



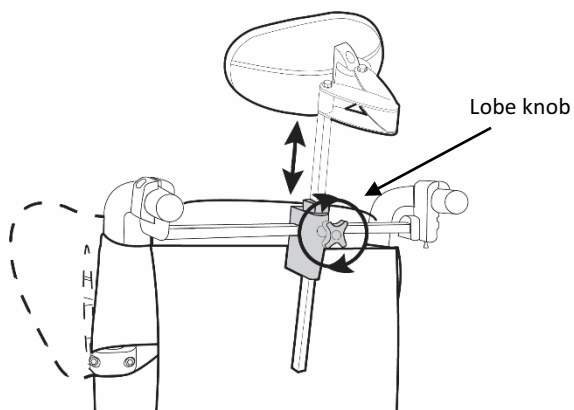
When using BACKUS & CURVUS backrests, SUMMUS is secured by a hardware system attached to the back canes of the wheelchair.

In addition, the stem onto which the headrest cushion is attached to, as a height lock set by the clinician to the desired height.



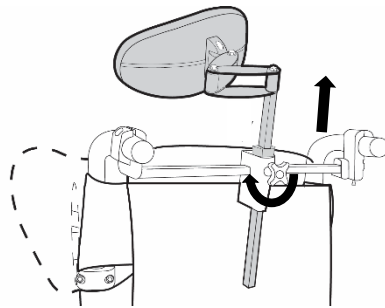
**WARNING :**

**THE HEIGHT LOCK SHOULD NEVER BE MOVED NOR THE CONFIGURATION OF THE MULTI-DIRECTIONAL SUPPORT MODIFIED.**



Turn **counter clockwise** the lobe knob to allow the insertion of the stem into the support all the way until the height lock comes in contact and is blocked by the backrest fastener.

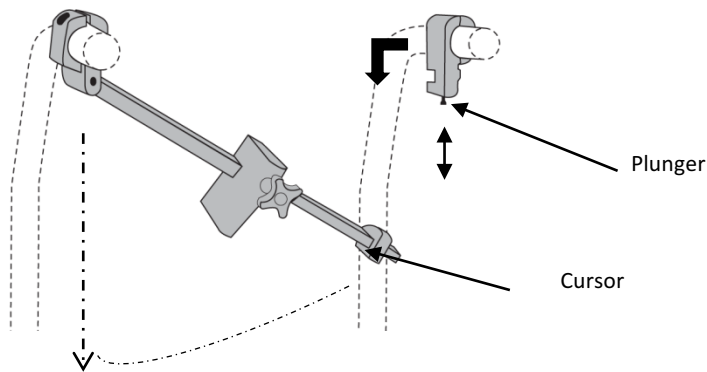
Turn **clockwise** the lobe knob to lock the stem in place.



To pull out the headrest stem, use the lobe knob and turn **counter clockwise**. TO AVOID LOSING THE LOBE KNOB, always keep it screwed into the backrest fastener.

This SUMMUS installation will allow you to fold your wheelchair when required.

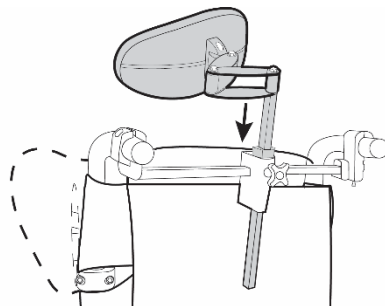
First, PULL OUT THE STEM OF THE HEADREST FROM THE SUPPORT. Secure the lobe knob back into position.



Pull down the plunger and push out forward the mounting bar from the anchor.

The mounting bar will then be free to fall in a vertical position.

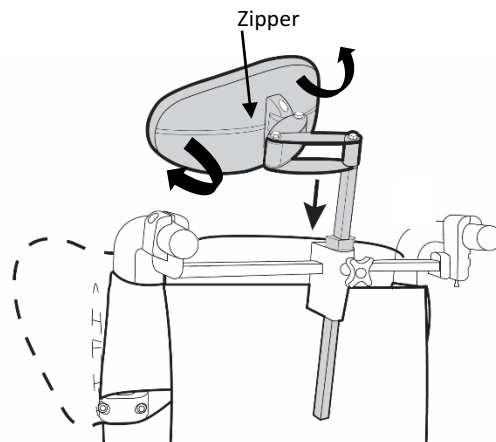
Proceed to folding the wheelchair as instructed by its manufacturer.



When reinstalling, use the cursor to guide you with the reinsertion of the mounting bar. Pull out the plunger, slide the bar into the anchor. Lock in place by push in the plunger.

Check that the mounting bar is well secure. Reinsert the headrest stem and close clockwise the lobe knob.

Unzip BOTH ZIPPERS of the  
cover and remove gently.

Hand wash in cold water with a  
mild detergent.

Dry flat.

Ensure that both sides are  
completely dry.



### WARNING :

**DO NOT MACHINE DRY.**

**DO NOT STEAM AUTOCLAVE.**

**DO NOT DRY CLEAN.**

**DO NOT USE BLEACH.**

**DO NOT USE FABRIC SOFTENER.**

Reassemble when fully dry.

BOTH ZIPPERS SHOULD  
ALWAYS BE FACING THE STEM.
